Article 3: Company Name

The name of the company is: [Knowledge Net Computer Co. Limited] [limited liability]

Article 4: Objectives of the Company

The objectives of the company are defined as follows:

The company carries out its activities in accordance with the applicable regulations and after obtaining the necessary licenses from the competent authorities, if any.

Article 5: Participation and Integration

The company may establish companies on its own (with limited liability or closed joint stock, provided that the capital is not less than (5) million PL). This is after fulfilling the requirements of the applicable regulations and instructions in this regard, and the company may also dispose of these shares, provided that this does not include mediation in their trading.

Article 6: The main office of the company

The main office of the company shall be in the city of [Riyadh] and the company shall have the right to open branches for it inside and outside the Kingdom when the interest of the company requires, by a decision [by the partners' decision].

Article 7: Duration of the Company

The term of the company is [25] Hungarian / Gregorian years starting from the date of its registration in the commercial register. The term of the company may be extended before its expiration for another period by a decision issued by the General Assembly from any number of owners' partners to describe the shares representing the capital or from the majority of the partners, and if the decision is not issued to

extend the term The company, and the company continued to perform its business, the contract was extended for a similar period under the same conditions contained in the Memorandum of Association. A partner who does not wish to continue in the company may withdraw from it, and his shares shall be established in accordance with the provisions of Article (161) of the Companies Law, and the extension shall not be implemented except after selling the share of the partner to partners or third parties, depending on the case, and paying its value to him, unless the partner agrees. The withdrawn with the rest of the partners otherwise.

Article 8: Capital

The company's capital was set at [1,500,000] hands [one million and one million five hundred thousand] Saudi riyals divided into [150,000] cash/in-kind shares) of equal value, and the value of each share was [10] Saudi riyals distributed to the partners as follows:

Article 9: Increase or Decrease the Capital

It is permissible with the approval of all the partners to increase its capital by raising the nominal value of the partners' shares or by issuing new shares, with obligating all the partners to pay the value of the increase in the capital in proportion to the participation of each of them. The general assembly of partners may decide to reduce the capital of the company if it exceeds its needs or if it suffers losses that do not amount to half of the capital, in accordance with the provisions of Article (seventy-seventh after (one hundred and seventy-seventh) of the Companies Law.

Article 10: shares

A partner may assign his share to one of the partners or to a third party. However, if a partner wants to waive his share, he informs the rest of the partners, through the company manager, of the terms of the assignment.

In this case, each partner may request its fair value within thirty days from the date of his notification. If the right of recovery is used by more than one partner, this share or stakes shall be divided among the claimants in proportion to the share of each of them in the capital. The right of recovery stipulated in this article does not apply to the transfer of ownership of the shares by inheritance or will or its transfer according to a judgment from the competent judicial authority.

Article 11: shares register

The company prepares a special register with the names of the partners, the number of shares owned by each of them, and the dispositions that occur to him. The company must notify the Ministry to record it in the company's register.

Article 12: Management of the Company

The company is managed by a manager who is specified in the company contract, and his powers are as follows

Dismissal of the manager: The partners may dismiss the managers appointed in the company's contract without prejudice to their right to compensation if the dismissal takes place without an acceptable justification or at an inappropriate time.

Article 13: Auditors

The company must have an auditor (or more) from among the auditors licensed to work in the Kingdom, to be appointed by the general assembly of partners, and his remuneration and duration of work shall be determined.

Article 14: The General Assembly of Partners

A limited liability company shall have a general assembly consisting of all partners. The General Assembly convenes at the invitation of (the manager or managers or the board of directors), provided that it is held at least once a year during the four months following the end of the company's fiscal year. The general assembly may be called at any time at the request of the supervisory board, the auditor, or a number of partners representing at least half of the capital.

Minutes are drawn up summarizing the discussions of the General Assembly, and the minutes and the decisions of the General Assembly or the decisions of the partners are recorded in a special register

prepared by the company for this purpose. It must include the agenda of the company's general assembly. The general shareholders in their annual meeting in particular on the following items:

1. Hearing the managers' report on the company's activities and its financial position during the fiscal year, the auditor's report, and the supervisory board's report, if any.
2. Discussing and approving the financial statements
3. Determine the profit percentage to be distributed to the partners
4. Appointing managers or members of the supervisory board, if any, and determining their remuneration.

Article 15: Decisions of Partners

1. The decisions of the partners are issued in the general assembly. (However, in a company that does not exceed twenty, it is permissible for the partners to express their opinions separately. In this case, the company manager sends a registered letter to each partner with the proposed decisions for the partner to vote on in writing.)
2. The company's articles of incorporation may be amended with the approval of (the majority of the partners) who represent at least (75%) of the capital, [provided that the percentage does not represent one partner]
The rest of the decisions are issued with the approval of the partners who represent (50%) of the capital, provided that the percentage does not represent one partner.]
3. If the majority stipulated in this paragraph is not available in the deliberation or in the first consultation, the partners shall be invited to the meeting by registered letters. Decisions shall be issued in the aforementioned meeting with the approval of the majority of the shares represented therein, whatever the percentage they represent in relation to the capital.

Article 15: Fiscal Year

The beginning of the company's financial year becomes from [24/05/1421] AH corresponding to [24/08/2000] AD and ends on [16/10/1422] corresponding to [31/12/2001] AD, and each fiscal year after that is twelve months.

The managers of the company shall prepare for each fiscal year the financial statements of the company and a report on the company's activities, its financial position and their proposals regarding the distribution of profits, within three months from the end of the fiscal year. The managers must send to the Ministry and to each partner a copy of these documents and a copy of the board's report

Oversight - if any, and a copy of the auditor's report, within one month from the date of preparation of the aforementioned documents. Each partner may ask the managers to convene a meeting of the partners' general assembly to deliberate on the aforementioned documents.

Article 16: Profits and Losses

The company's annual net profits are distributed as follows:

- A- The company shall set aside at least (10%) of its net profits every year, to form a statutory reserve. The general shareholders may decide to stop this reserve when the aforementioned reserve reaches (30%) of the company's capital.
- B- The remainder is distributed to the partners in proportion to their shares in the capital, unless the partners decide to form other reserves or carry over the balance of profits, in whole or in part, to the next fiscal year.

- C- In the event of realizing losses incurred by the partners in proportion to the shares owned by each of them in the capital, or they are carried over to the next fiscal year, and no profits are distributed except after profits, except after amortizing that loss, and if the company's losses amount to half of its capital, the (manager, managers, or board) must The managers (the company) register this incident in the commercial register and invite the partners to meet within a period not exceeding ninety days from the date of their knowledge of the loss reaching this amount; To consider the continuation or dissolution of the company. The partners' decision, whether to continue the company or to dissolve it, must be declared in the ways stipulated in Article (158) of the Companies Law. The company shall be considered dissolved by the force of the law if the company managers neglect to invite the partners or if the partners are unable to issue a decision to continue the company or to dissolve it.

Article 17: Termination of the Company

The company is terminated by one of the reasons for termination mentioned in Article Sixteen of the Companies Law and Articles

Upon its expiry, the contract enters the stage of liquidation in accordance with the provisions of Chapter Ten of the Companies Law.

Bearing in mind that in the case of voluntary liquidation, the following must be taken:

1. Preparing a financial position for the company on the date of issuance of the partners' decision to dissolve and liquidate the company, approved by a chartered accountant licensed to work in the Kingdom of Saudi Arabia, proving the company's ability to fulfill its obligations and debts towards third parties.
2. Paying all the rights of the creditors or concluding a reconciliation with them. If this is not possible, the company will not be liquidated except after the issuance of a decision by the competent judicial authority declaring the company bankrupt at the request of the creditors.

Article 18: Notifications

Notifications sent by the company to the partners shall be by e-mail

Article 20: General Provisions

1. The company is subject to the regulations in force in the Kingdom.
2. All that is not stipulated in this contract shall be subject to the Companies Law and its Bylaws.

Article 21: Copies of the contract

This contract was issued from a number of copies received by the owner of the capital to work according to it and to submit it to the competent authorities for the registration of the company in the commercial register and the companies register. This has authorized the partners Mr. IBRAHIM AYED AJIM AL SAAD AL-QAHTANI to complete the necessary legal procedures for the establishment of the company and follow-up with the competent authorities in this regard.

The partners, with their full legal and legal capacity, acknowledge their agreement to the company's contract and that they have carefully reviewed its clauses and the obligations and rights it contains, and that they acknowledge its validity and non-contravention of the corporate law, and they submit it voluntarily and freely, without coercion or coercion from anyone, and that they are responsible for the

validity of all data and information entered and received. And they bear the statutory responsibility in accordance with Article 212 of the Companies Law, if proven otherwise.
